# PLANNING COMMISSION REGULAR MEETING

#### **SEPTEMBER 24, 2020**

#### GENERAL PUBLIC COMMENT PERIOD

- 1. 2020-033 ZA, APC for Anthony & Lana Teresi: Anthony and Lana Teresi filed a California Land Conservation Contract Application to add 9.94 acres of land to their existing Agriculture Preserve Contract 351 for a total of 206.09 acres. The County is processing a zoning amendment for APN 020-013-011 from U (Unclassified) to AP (Agriculture Preserve). The subject property is located at 19600 Potteroffs Road, ¾ of a mile north of the intersection of Jesus Maria Road and Baker Riley Way. APN: 020-004-014, 015 and 024 are located in portion of Section 16 and APN: 020-013-011 is located in a portion of Section 15, all in T05N, R13E, MDM. This project is categorically exempt from CEQA pursuant to §15317 of the CEQA guidelines. (Gina Kathan, Planner III)
- 2. 2020-026 ZA, APC for Richard, Carla & Romie Rolleri: Richard, Carla and Romie Rolleri filed a California Land Conservation Contract Application to establish Agriculture Preserve Contract 378 for a total of 1,465.35 acres. The County is processing a zoning amendment for all 41 Assessor Parcels from interim zones Unclassified (U) and Highway Service (HS) to Agriculture Preserve (AP). The subject properties, totaling 1,465.35 acres of land, are located east of Schmauder Mine Road, north of the City of Angels City Limits, both west and east of Murphys Grade Road to SR4 at Six Mile Road. APNs: 057-001-010 & 013 are a portion of N ½ Section 21, APNs: 057-002-010, 014 & 015 are a portion of the S ½ of Section 21, APNs: 057-003-018, 023, 024, 070, 071, 072 & 074 are a portion of Section 23, APNs: 057-011-004, 005, 006, 010 & 012 are a portion of the S ½ of Section 22, APNs: 057-015-001, 002, 003, 004, 005, 006 & 019 are a portion of the N ½ of Section 26, APNs: 057-019-001. 002, 003, 007, 019, 020 & 020 are a portion of the N ½ of Section 27, APNs: 057-020-008 & 031 are a portion of the N ½ of Section 28, APN: 057-023-029 is a portion of the N ½ of the SE ¼ of Section 28, APNs: 057-024-003, 004, 019, 020, 021, 022 & 027 are a portion of the S ½ of Section 27, T03N, R13E, MDM. This project is categorically exempt from CEQA pursuant to §15317 of the CEQA guidelines. (Gina Kathan, Planner III)
- 3. <a href="Project 2020-064 LAND USE MAP">Project 2020-064 LAND USE MAP</a> (FIGURE LU-1) GENERAL PLAN AMENDMENT: Calaveras County is proposing to amend the General Plan to correct errors on Figure LU-1, the Land Use Map.
