RECOMMENDATION:

Accept donations from the Friends of the Calaveras County Sheriff's Office (FOCCSO) totaling \$23,627.31 and recognize FOCCSO for their continued support of the County Sheriff's Office.

DISCUSSION/SUMMARY:

Friends of the Calaveras County Sheriff's Office (FOCCSO) is a 501(c) (3) charitable organization whose mission and goals are to support the programs and operations of the Calaveras County's Sheriff's Office (CCSO) since 2012. Over the years they have supported CCSO with valuable donations to help with programs and operations.
