RECOMMENDATION:

Authorize the Board Chair to execute an Agreement with Samantha Cooper for the provision of mental health services for a not to exceed value of \$100,000 for the period of July 1, 2019 through June 30, 2021.

DISCUSSION/SUMMARY:

The Calaveras Health and Human Services Agency – Behavioral Health Services Mental Health Program (MHP) is responsible for serving seriously emotionally disturbed children and youth. The MHP provides assessment, group therapy, crisis intervention, medication services, case management, and supportive services to these children and their families. The MHP has developed a network of licensed private providers in local communities to provide increased access to mental health services for children with emotional and/or behavioral disorders.

The current Agreement with Samantha Cooper, a local community based provider, is to serve children referred on an as-needed basis, whom are also assessed by MHP personnel prior to referral and service authorization.

FINANCING:

Approval of this agreement will have no impact to the County General Fund.

The total maximum amount payable under this Agreement shall not exceed one hundred thousand dollars (\$100,000) during the period of July 1, 2019 through June 30, 2021. Costs are paid utilizing Medi-Cal reimbursements and local mental health Realignment funds. Appropriate expenditures for this Agreement are included in the Fiscal Year 2019-20 MHP Budget 10620010-5271 and will be budgeted in subsequent fiscal years.

ALTERNATIVES:

The Board may choose to do any of the following:

- A. Uphold the Departmental recommendation to approve this amendment.
