Commercial Cannabis Tax

NOTICE IS HEREBY GIVEN THAT on June 21, 2016, the Board of Supervisors of Calaveras County introduced an Ordinance entitled: AN ORDINANCE SUBMITTING TO THE VOTE OF THE ELECTORATE A MEASURE TO IMPOSE A COMMERCIAL CANNABIS TAX ON OUTDOOR/ MIXED LIGHT CULTIVATION AT THE RATE OF \$2.00 PER SQUARE FOOT OF CANOPY AREA UNTIL THE DEPARTMENT OF FOOD AND AGRICULTURE HAS ESTABLISHED AND IMPLEMENTED A TRACK AND TRACE PROGRAM UNDER BUSINESS AND PROFESSIONS CODE 19335 ET SEQ, AT WHICH TIME THE TAX RATE SHALL BE: \$45.00 PER POUND OF DRY WEIGHT FLOWER AND BUD AND \$10.00 PER POUND OF DRY WEIGHT TRIM; AND A COMMERCIAL CANNABIS TAX ON INDOOR CULTIVATION AT THE RATE OF \$5.00 PER SQUARE FOOT OF CANOPY AREA, UNTIL THE DEPARTMENT OF FOOD AND AGRICULTURE HAS ESTABLISHED AND IMPLEMENTED A TRACK AND TRACE PROGRAM UNDER BUSINESS AND PROFESSIONS CODE 19335 ET SEQ, AT WHICH TIME THE TAX RATE SHALL BE \$70.00 PER POUND OF DRY WEIGHT FLOWER AND BUD AND \$15.00 PER POUND OF DRY WEIGHT TRIM; AND A GROSS PROCEEDS TAX OF SEVEN PERCENT (7%) ON THE MANUFACTURING OF CULTIVATED CANNABIS; AND A GROSS PROCEEDS TAX OF SEVEN PERCENT (7%) ON RETAIL MEDICINAL OR LEGAL CANNABIS STOREFRONTS, COLLECTIVES, AND DISPENSARIES, FOR GENERAL

GOVERNMENTAL PURPOSES. The proposed Ordinance will add Chapter 3.56 to the Calaveras County Code for the purpose of taxing commercial cannabis cultivation at rates stated in the ordinance. The Ordinance is scheduled for adoption on July 12, 2016, and if adopted, will go before the voters at the November 8, 2016 general election. If passed by a majority vote of the electorate, the Ordinance will go into effect immediately with tax bills for 2017 issued to cannabis cultivators no later than May 2017, payable in two installments annually.
