SECOND AMENDMENT TO AGREEMENT FOR SERVICES FOR INMATES OF CALAVERAS COUNTY ADULT DETENTION FACILITY BETWEEN COUNTY OF CALAVERAS AND CALIFORNIA FORENSIC MEDICAL GROUP, INC.

This Second Amendment to the Agreement for Services for Inmates of Calaveras County Adult Detention Facility between County of Calaveras, a political subdivision of the State of California ("County") and California Forensic Medical Group, Inc., a California Corporation ("Contractor"), dated October 1, 2015 ("Agreement"), is entered into as of the date set forth above ("Amendment"). This Amendment is effective January 25, 2018

RECITALS

Whereas, the County and the Contractor entered into the Agreement to provide health care services to inmates and detainees in the custody of the Calaveras County Sheriff and County;

Whereas, the First Amendment to this agreement ("the First Amendment") extended the term of the contract from June 30, 2018 to June 30, 2019 as well as added additional medical services for the Calaveras County Adult Detention Facility effective January 1, 2018;

Whereas, this Second Amendment amends the staffing plan attached and incorporated into the First Amendment as "First Amendment to Exhibit B – Staffing"; and

Whereas, the County and the Contractor wish all provisions to remain the same;

Now, therefore, the County and the Contractor agree to the revisions set forth in this Second Amendment to the Agreement for Services for Inmates of Calaveras County Adult Detention Facility as follows:

First Amendment to Exhibit B, (referred to in the First Amendment as "Exhibit B—Staffing") shall be replaced in its entirety with a revised "Exhibit B—Staffing", which is attached and incorporated by reference into this Second Amendment.


