

ADMINISTRATIVE MATCH AGREEMENT

between the

COUNTY OF CALAVERAS

and

AREA 12 AGENCY ON AGING

THIS AGREEMENT, made and entered into this 1st day of July, 2019, by and between the **AREA 12 AGENCY ON AGING** in its capacity relating to the joint exercise of powers common to the agencies pursuant to the provisions of Article I (commencing with Section 6500), Chapter 5, Division 7, Title I of the Government Code of the State of California, hereinafter referred to as **AGENCY**, and **CALAVERAS COUNTY**, hereinafter referred to as **COUNTY**:

WITNESSETH

WHEREAS, **AGENCY** is required to provide an administrative match to funds provided for such purposes by the Older Americans Act and the Older Californians Act.

WHEREAS, the Joint Exercise of Powers Agreement creating the **AGENCY** and the Older Americans Act and the Older Californians Act allow such match to be provided through cash and/or in-kind services.

WHEREAS, pursuant to the Joint Powers Agreement, **COUNTY** is able and desires to provide its proportionate share of the administrative match as cash to the **AGENCY**;

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. GENERAL PROVISIONS

- 1.1 **COUNTY** agrees to provide on demand no later than September 30, 2019, or as agreed by the Area 12 Agency on Aging Governing Board the cash described in EXHIBIT A at the request and direction of the **AGENCY**.

2. TERMS OF THE AGREEMENT

- 2.1 This Agreement shall be effective from July 1, 2019 through June 30, 2020.

WHEREAS AGENCY is required to provide an administrative system in funds provided to such purposes by the Older Americans Act and the Older Californians Act.

WHEREAS the joint exercise of Powers Agreement creating the AGENCY and the Older Californians Act and the Older Americans Act allow such mission to be provided through each and/or in-kind services.

WHEREAS pursuant to the joint Powers Agreement COUNTY is able and desires to provide its proposed share of the administrative mission as set forth in the

NOW THEREFORE IT IS AGREED AS FOLLOWS:

GENERAL PROVISIONS

1. COUNTY agrees to provide on demand on or before July 1st of each year to the AGENCY on Aging Governing Board the cash described in EXHIBIT A at the request and direction of the AGENCY.

TERMS OF THE AGREEMENT

2. This Agreement shall be effective from July 1, 1979 through June 30, 1980.


