

AMENDMENT TO SWANSON SERVICES CORPORATION COMMISSARY SERVICE CONTRACT, COBRA SMARTCARD SERVICE AGREEMENT, COBRA COMBO BOOKING CASHIER AGREEMENT, COBRA COMBO CASHIER SERVICE AGREEMENT, COBRA BANKER SOFTWARE CONTRACT ADDENDUM, COBRA TELELINK SERVICE AGREEMENT AND COBRA PHONE-IT-IN SERVICE AGREEMENT

This Amendment to the Swanson Services Corporation Commissary Service Contract, Cobra Smart Card Service Agreement, Cobra Combo Booking Cashier Agreement, Cobra Banker Software Contract Addendum, Cobra TeleLINK Service Agreement and Cobra Phone-It-In Service Agreement is made by and between Calaveras County Sheriff's Office, located at 1045 Jeff Tuttle Drive, San Andreas, CA 95249 (hereinafter referred to as "Client") and Swanson Services Corporation, a Florida corporation with its principal office at 10880 Lin Page Place, St. Louis, MO 63132 (hereinafter referred to as "Swanson"). Swanson and the Client are referred to as the "Parties".

WHEREAS, the Parties have entered into a Swanson Services Corporation Commissary Services Contract dated July 1, 2010, by which Swanson provides commissary services at the Calaveras County Sheriff's Office, and

WHEREAS, the Parties have also entered into a number of collateral Agreements including the following: Cobra Smart Card Service Agreement, Cobra Combo Booking Cashier Agreement, Cobra Banker Software Contract Addendum, Cobra TeleLINK Service Agreement and Cobra Phone-It-In Service Agreement by which Swanson provides certain hardware and software associated with and in support of the commissary services, and

WHEREAS, the Parties entered into an Addendum to the Inmate Commissary Service Contract dated the 26th day of April, 2013 and a Payment Processing Addendum made effective the 28th day of July, 2015 (the Swanson Services Corporation Commissary Service Contract, the collateral Agreements listed above, the Addendum dated the 26th day of April 2013, and the Payment Processing Addendum are referred to herein collectively as the "Agreement"), and

WHEREAS, the Parties entered into an Amendment dated the 14th day of September, 2016, that extended the term of the Agreement to June 30, 2018 and memorialized other administrative changes agreed to by the Parties,

WHEREAS, the Parties entered into an Amendment dated the 15th day of June, 2018, that extended the term of the Agreement to June 30, 2019 and memorialized other administrative changes agreed to by the Parties, and

WHEREAS, the parties now desire to further extend the Agreement as stated herein.

NOW, THEREFORE, in consideration of the forgoing facts, the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree follows:

1. The foregoing recitations are true and correct and made a part hereof.

2. The Parties hereby confirm that they have mutually agreed to extend the term of the Agreement for an additional one (1) year term expiring June 30, 2020. Thereafter, by mutual written consent, the Parties shall have the option to further extend the term of the Agreement for one additional one (1) year term.

3. This Amendment shall be deemed effective as of July 1, 2019.

4. Except as expressly stated herein, all of the terms and conditions of the Agreement shall remain in full force and effect.
