The following terms and conditions shall be amended.

**2. COMPENSATION AND PAYMENT**

**2.1 Total Compensation:** For the services described in Section 1 above, and subject to the condition that the specified task has been completed as set forth in Section 1.3 above, Contractor shall be paid for mental health services provided to Medi-Cal Beneficiaries as authorized by the County at the rate of two and 13/100 dollars (\$2.13) per minute, and shall not exceed time of authorized service as indicated by CPT codes, unless approved by the Director of Health and Human Services. These services will be provided on an as-needed basis by the Contractor. Mandatory and voluntary attendance at County-sponsored trainings or other activities are unpaid. Any mileage, expense reimbursement, additional training, or employment benefits are the sole responsibility of the Contractor. The total amount of compensation to be paid Contractor for the services described in Section 1 shall not exceed three hundred thousand dollars (\$300,000).

**2.2 Expense Reimbursement:** Contractor shall not be entitled to reimbursement for any expenses other than those described in Section 1 above.

No funds paid to Contractor through this Agreement shall be utilized to compensate employees of Contractor for overtime or compensatory time off, except to the extent that Contractor is required to pay for overtime or compensatory time off pursuant to the Fair Labor

Standards Act of 1938, 29 USC Section 201 et seq., or applicable State law.

**2.3 Overpayment:** If County overpays Contractor for any reason, Contractor agrees to return the amount of such overpayment to County or at County's option, permit County to offset the amount of overpayment against future payments owed to Contractor under this Agreement or any other Agreement.

All other terms and conditions shall remain unchanged.
